#### How to Increase Tax Revenue From Short-Term Rentals

As COVID-19 restrictions are lifted, municipalities can expect to see a surge in those seeking vacations and travel. # O1 CREATE STRATEGIC SHORT-TERM RENTAL ORDINANCES

#### Why It Matters

Without strategic ordinances, the STR industry can be difficult to enforce. Your ordinances should be clear, enforceable, and align with the goals of your community. If your ordinances require high burdens of proof (e.g. catching violators by knocking on doors), it will be difficult, if possible, to enforce your codes. Violators are less likely to come into compliance and pay taxes without fear of repercussions.

#### What to Consider

You may have heard of Airbnb and HomeAway, but did you know that there are over one hundred STR platforms online? When implementing new policies, it's important to consider how you will monitor and enforce STR activity across a wide range of platforms. STR compliance software can help you determine number of stays and calculate taxes owed for STRs on multiple platforms, providing overall visibility and better insight into taxes owed.

## O2 EDUCATE HOSTS ON COMPLIANCE REQUIREMENTS

#### Why It Matters

Education is an opportunity for government to inform citizens of local laws and their importance. Without education, only about 10% of STR hosts will come into compliance with local laws. Once hosts are aware of ordinances, most of them will get registered and begin to pay taxes.

#### What to Consider

Your website and social media only reach so far. You need to communicate with hosts directly to make sure you are being heard. STR compliance software can identify the addresses and property owners of STRs. Once you know who is operating — legally and illegally — and where, you can use software to send them letters that communicate your ordinances and how to become compliant.

## Ask Yourself

- Do I know where STRs are in my community and who is operating them?
- Have I communicated ordinances directly to hosts?
- Have I informed them of ways to come into compliance?





#### Why It Matters
